## **Eol Submission Tutorial File**

# Before Starting EoI submission form, following Information must be ready with the Applicant

- 1) Unique Identification Numbers of the Sectors for which Applicant is interested in Submitting EoI from NDR site
- 2) Ready to make online payment of INR 500000 as application Fee.
- 3) Scan copy of Participation Bond of Requisite amount.
- 4) Scan Copy of Due-Diligence report of Prospectivity as per the Format provided.

### **Steps for Submitting Eol**

#### 1) Selecting Unique Identification Numbers of the sectors of your interest from NDR site

- a) Register at NDR site https://www.ndrdgh.gov.in
- b) Login with your NDR credentials and the Landing Page will be as given below :



c) Please select all the layers as shown below to get the information about existing PEL/ML areas, No Go areas, availability of data and zones classification.



d) Using Zoom In and Zoom Out Tools placed at the right of the window, focus on the area of your interest.



After focussing into the area, two Informations viz Unique Identification number of the 10'X10' sector and classification of the area i.e zone 1, zone 2 and zone 3 will be clearly visible.

(Zone 2 and zone 3 are the areas where EoIs for Reconnaissance Contract can be submitted)

Further, division of 10'X10' sector into 1'X1' areas is not displayed on the layer at NDR, if the applicant wants to submit EoI comprising of area in 1'X1' and/or partial 1'x1' grids, then please send a request at facilitationoal@dghindia.gov.in by mentioning the unique identification number of 10'X10'sector for which the applicant needs further division in to 1'X1' and/or partial 1'x1' grids.

Units less than 1'x1', in polygonal manner with curved/straight lines connecting corner points, will be allowed in the EoIs if complete 1'x1' grids are not available to cover area along natural boundaries like coastlines, State & International borders, boundaries of forests, national parks, riverine areas, sanctuaries, restricted/ No-Go zones, including intervening area among already awarded blocks etc.

- c) After Login, applicant will land up on the page as shown below:
